## Activities:

### 1. Silk Garland Production Training

Training is the key objective of silk garland production program to the Seri culturists. Selection of trainees from five VDCs was very challenging. Because there were targeted 50 farmers to provide skill full training through out the year. DSDP has decided 3 batches training schedule instead of two. The special committee was formed to select the trainees as in previous batches. The committee was constituted from different institutions such as local political leaders, intellectual circles, lead farmers, group members, local teachers and organization's members. The committee developed criteria to select the trainees fairly from all aspects.

1. At first, Trainees should be from sericulture Development Groups.
2. Secondly, those farmers who are continuously rearing the silk worm larvae will get first priority.
3. Trainees should be from low cast, at list mulberry growers and women farmers.
4. Equal opportunity to all the VDCs on the basis of mulberry cultivation and plantation in numbers.
5. At last, interested farmers who are willing to cultivate mulberry plants.

Considering the above facts and criteria, Trainees were selected from 5 VDCs in second and third batch of training program.

In this way, the silk garland production training was organized 3 times in the training center in Dapcha, Kavre. The training period was of 45 days for single batch of participants. Two facilitators were providing skill and knowledge to the participants through out the whole training session. On the other hand, frequently guest lecturers were also invited from concerned organizations and line agencies.

All the rule and regulation were strictly followed of the training program. Participants were selected as per the norms and criteria sketched by the selection committee. The training was completed in harmonious manner. Organization has been succeeded to leave a different positive impact to the participants and people of Dapcha. Nearly one year spent to select trainees, organize series of meetings, class conduct, and frequent exhibition of silk garland locally and nationally, frequent visitors coming from different organizations. It was a unique situation in the village that longer training period and daily routine to join classes by the rural women, busy in income generating activity and self employment.

In this way, Program period has become very short and acute.

## 2. Silk Garland Production During the Training Period:

Farmers had no single idea about the silk garland. But they have heard about it. Almost all farmers were women. They were familiar with other type of garland such as flower garland. Farmers were involved having keen interest in the training period. They were hurry up to provide size and shape in to a garland form. Designing, cutting, selection of uniform cocoon and cutting in to uniform size and shape really was challenging and tough job to the farmers hand. Coloring and matches of color in to garland as per the demand in the modern interest and new fashionable market. Even though, they were produced number of silk garlands as recorded in the organization are as follows.

#### 4. Silkworm Rearing

DSDP organized an young age worm rearing activity in it's silkworm rearing center. The third age instars larvae were distributed to the mulberry farmers. Such types of two young age worm rearing centers were supported financially by DSDP Rupees 10000/- each. In DSDP inspired this way, to the Seri culturists to grow more mulberry and to rear more silkworm larvae. According to the information of Sericulture Development Section, Khopasi, around 500kg.of cocoon produced from this pocket area. Sericulture farmers are happy getting support from DSDP. One farmer named Gyani Maya Tamang sold cocoon to the garland production program and receive more money in per kg of cocoon price than the fixed rate of Government price. She received Rupees 8000/- in one crop. She reared silkworm larvae 3 times in a year.

Seri-farmers have encouraged towards the sericulture farming . They received support in different aspect such as technicians, young age worm rearing facilities, disinfectants and CRC labor charges too.

## 5. Mulberry Plantation and Plantation Training

One meeting of mulberry demand collection was organized in the presence of technical officers of Sericulture Development Section, Khopasi before monsoon. Altogether 10000 mulberry saplings was demand and fund collected from the farmers as well as submitted and order placed to the SDS office.

Finally 10000 mulberry saplings received from the SDS and distributed to the farmers as shown in the following table.

In 3<sup>rd</sup> of Shrawan, one plantation training of one day was organized in the training center of Dapcha. The participants were the member's of Shrijansil Gramin Mahila Samuha and interested mulberry growers.

Two agriculture officers were facilitate to the mulberry plantation training. One thousand mulberry saplings were planted in the land of training center during the course of training period.

## 6. Exposure Tour to the trainees

Exposure tour helps to refreshes the participants in between the training period. Exposure trip is one of the main topics of the training program. Following this objective, one exposure tour was provided to each batch participants. All participants had joined in the tour program. Main venues, objective of the visit, route and transport were finalized by the participants.

One of the main exposure spot was SDS, Khopasi. This is the main concerned organization of the Seri-farmers. The farmers were treated very nicely in term of technical guidance, idea sharing, unit demonstration and class conduct. Exposure tour really became helpful in two proposes.

1. To build up relation between farmers and organization
2. To receive enough data and information from the main organization of the sericulture program.

In this way, the exposure tour was help full to both parties for the promotion of sericulture activities.

## 7. Group Formation

A sericulture group has been formed in the main location of Chhatrebanjh VDC. The main objective of the group is to promote the sericulture activities including silk garland program. The name of the group has been kept **Shrijansil Gramin Mahila Vikash Samuha**. The members of the group are 28 in number. The group organize meeting once in a month. They collect money and raise the saving fund. They have maintained account register, minute book, and money lending file too. DSDP has plan to develop them and encouraging to be a legalized institution with providing registration in the District Administration Office, Dhulikhel.

The group is coordinating with other line agencies such as Sericulture Development Section, Khopasi and Agriculture Development Office, Dhulikhel.

After 3<sup>rd</sup> batch of training, a closing ceremony was organized on 10 of Aashadh 2066. All 51 trainees of three batches were presented to fetch their certificate. Chief Guest and guests were invited from donor agency and concerned line agencies. VDO and journalists were also invited on the occasion. The closing ceremony in the village area was really converted in to festival. The program was started around 11AM of 10 Aashadh. The program was chaired by the chairperson of the host organization and similarly chief guest was chaired by the chief of Sericulture Development Section, Khopasi. #### **11 Marketing Management**

Silk garland is a very new product in Nepal. There is no where any introduction, impotency, and it's value given in book, magazine, paper or any advertisement. DSDP has given maximum priority to provide information through electronic media. First of all, it published in the national daily news paper "**Gorkha Patra**". Similarly, DSDP has developed a documentary film including silk garland production. It disseminated the technology and use of silk garland through Division of Agriculture Information and Communication named as "**Krishi Karyakram**". On the other aspect, DSDP has developed an advertisement film to provide television channel in the assistant of advertisement agency. The advertisement has submitted all kind of information, importance and various uses of silk garland through **ABC Television**. It can be seen to the report submitted. Advertisement will be continuing in Ashadh/Shrawn, 2066. Time of advertisement in ABC television channel is 7AM morning, 3 PM in afternoon and 8 PM in evening and 9 PM in late evening in between news broadcasting time.
